# Snake River Basin Adjudication

- Final Unified Decree –
   Signed August 25, 2014
  - 158,693 decrees
- Idaho Code § 42-1413
  - Filed in each SRBA county recorder's office
  - Will direct public to IDWR for current status



- Summary Supplemental Adjudication
  - Idaho Code § 42-1424



## Northern Idaho Adjudication (NIA)

- Proceeding as a general adjudication
  - Idaho Code § 42-1406B(1)
- Jurisdiction is with the Fifth Judicial District Court in Twin Falls (SRBA District Court)
  - Idaho Code § 42-1406B(2)



# Basins 91 - 95 - Couer d'Alene and Spokane River Basins

# NIA Phase 1 (CSRBA)

Commenced Nov. 12, 2008 Basin 95 to be reported early 2018



# **Basin 87 - Palouse River and Tributaries**

# NIA Phase 2 (PRBA)

Commencement January 2017 Claims Taking Expected at the end of 2018



# Basins 96 & 97 - Clark Fork and Pend Oreille River Basins

# NIA Phase 3 (CFPRBA)

Likely will not commence





## NIA Participation and Deferment

- Who must participate?
  - State water users, Federal government, Tribes
- Who may defer?
  - Domestic and stockwater users
    - Idaho Code § 42-1406B(1)
      - Defer at your own risk
- Three phases

# Reserved Water Rights

- Idaho Code § 42-1411A
  - Claimant must provide notice
    - "Abstract" of the claim will appear in IDWR's Director's Report
  - Same objection/response deadlines as state-based
  - Ultimate burden of persuasion rests with claimant
  - CSRBA district court determines the elements, not IDWR
- Coeur d'Alene Tribe
  - Winters doctrine
    - Priority dates to creation of the reservation
    - Amount of water necessary to accomplish the purpose of the reservation
  - Requires meeting with public caucus.

Coeur d'Alene Lake	1	95	Maintenance of natural Lake Elevation (2,120' – 2,129')

- Present and Future Needs on Trust and Tribal Fee Land
- Priority Dates from "Time Immemorial" to 11/08/1873

# Coeur d'Alene Tribe Reserved Water Rights Status (91-07755)

- CSRBA District Court Decision
  - May 3, 2017 Order on Motions for Summary Judgment
    - Rejected homeland theory
    - Agriculture, fishing and hunting are primary purposes
    - No off-reservation right
    - Priority date
      - Time immemorial for fishing and hunting
      - 11-8-1873 for agricultural uses
      - Reacquisition date for reacquired lands or under state law (on reconsideration)
    - Lake level maintenance for fish and wildlife on reservation
- Settlement Negotiations
  - Started in Spring of 2015
  - Waiting to see if they will resume.




# Coeur d'Alene Tribe Reserved Water Rights Status (91-07755)

- Appeal
  - Coeur d'Alene Tribe filed 9-1-2017
    - Purposes of the reservation and priority date
  - United States filed 9-6-2017
  - State of Idaho filed 9-6-2017
    - On-reservation in-stream flow water rights
    - Future water right for fish hatchery
    - Lake level maintenance water right for fish and wildlife purposes
    - Springs and seeps
    - Priority dates to creation of the reservation
    - Amount of water necessary to accomplish the purpose of the reservation
  - North Idaho Water Rights Alliance filed 9-6-2017
    - Hunting and fishing ad primary purpose
    - Groundwater
    - Instream flow claims
    - Lake level claim



# Bear River Basin Adjudication



- November 2017 letter anticipated to legislators regarding funding the adjudication
- IDWR held dozens of Public Meetings 2014
- Bear River Commission meetings fall 2017
