AGENDA

Welcome and Introductions – Vice President BiJay Adams called the meeting to order at 1:34 pm. President Terry Pickel had a conflict and was not able to attend.

Agenda Additions or Revisions – No changes were requested.

Approval of Meeting Minutes – VP Adams called for additions or corrections to the October 12, 2021, meeting minutes. Shane Sheppard moved to approve the October minutes. Doug Greenlund seconded the motion. VP Adams called for a vote and the motion passed.

Financial Report – No financial report was available for November 2021.

Old Business

Water Conservation Planning Media Campaign - VP Adams introduced the desire to leverage resources with SAJB and other organizations to develop a regional water conservation focus. Below is a list of media campaign ideas for consideration:

- The media campaign should start by April 2022 when residents start turning on their irrigation systems.
- Focus on planting drought tolerant, native, and low water need plants.
 - o Regional soils vary and can determine the quantity of water required to sustain plant growth.
 - Contact Kara Carlton U of I Master Gardeners and Kristen Zimmer for WSU Master Gardeners.
 - o Introduce native plants that deer will not eat.
 - Native plants require less maintenance and give you more time to recreate
 - o Link the water conservation message to enjoying the Spokane River.
 - o IWAC can host a list of native plants and links to resources on the website.

- o Whitworth Water District has a xeric demonstration garden.
- o CDA has a demonstration garden using horse troughs and wick watering.
- o Create a Google map (tour) of native plants demonstration sites around the ID and WA region.
- Contact Kristen Zimmer for video clips of examples of walking tours.
- o Spokane Conservation District has native plant handouts.
- o Create a brochure for new residents that identifies native and drought tolerant plants.
- Work with a brewery to create an IWAC IPO Aquifer Beer. (Todd Henry may have a contact)
- Have a live event to enjoy aquifer beer and wine.
- Keep the focus on using water efficiently throughout the region.

Aquifer Atlas Updates – Alyssa Gersdorf described the work being done to reorganize and update the Business section pages 23-24. The 2022 Business pages will show business photos before technical assistance and after the business completed the recommended Best Management Practices. Information on the Panhandle Health District Critical Materials Program, Spokane River Forum EnviroCertified Program and the Pre-Treatment programs in ID and WA will also be included. Tonilee Hanson described the proposed changes for Aquifer Protection in the Home (pages 25-26). Most of the information will remain the same. The water conservation practices inside the home will be replaced by best practices outside the home. The Aquifer Atlas redesign team will meet on 11/17/21 to review an RFP for a Graphic Designer for the 2022 Aquifer Atlas redesign.

IWAC 2022 Goals and Accomplishments – A report of <u>IWAC Accomplishments from 2012 – 2021</u> was shared. A second spreadsheet linked the IWAC accomplishments to the <u>2013 IWAC Purpose and Goals</u>. IWAC 2022 Goals need to consider all of the work done to date and identify next steps. Members were asked to review the IWAC Accomplishment Document and the Goals document for setting 2022 Goals at the December 14, 2021, meeting. The IWAC accomplishments could be used to engage more membership participation and recruit new members.

Guinness World Record Opportunity from DEQ and IWEF – President Pickel was absent, and no update was provided.

New Business

IWAC 2022 Budget – Tabled to December 2021 – Tonilee Hanson will collaborate with Treasurer Ron Wilson to update the 2020 Budget spreadsheet with 2021 actual funds received and expended.

GSI Aggregate Quarry Risk Assessment - SAJB President, Jeremy Jenkins, reported that SAJB requested a scope of work (SOW) from GSI Water Solutions to develop a risk assessment for decommissioned gravel pits. A subcommittee met on 11/3/21 to discuss the SOW. SAJB is looking for a long-term solution that will provide a means to protecting the aquifer. Gravel pits involve a complex regulatory scenario in Washington. Jurisdiction includes the WA Department of Commerce, Ecology, the City of Spokane Valley, Department of Natural Resources, and Spokane County. Are aggregate quarries an issue in Idaho?

Partnerships are important. Who else should be included in these discussions? SAJB will apply for a Source Water Protection (SWP) grant from the Department of Health Division of Drinking Water. Tonilee Hanson wondered about working with the Lands Conservancy to acquire the land. Norm Semanko said that it was not hard to do a conservation easement. Doug Greenlund shared that one issue in conserving the property might be outstanding reclamation requirements. This is a complex issue that has no quick solution. SAJB may request letters of support from IWAC and APD for the SWP grant.

Ty Wick Defender of the Aquifer Award — On-line Nominations are Due Feb 15, 2022 — A media campaign will begin December 1, 2021, and run through February 15, 2022. Nominations will be accepted from Idaho and Washington for anyone working to protect the SVRP aquifer. Please review the TY Wick Award pages and send any edits.
