Welcome and Introductions – IWAC Vice President BiJay Adams welcomed everyone and called the meeting to order at 1:32 pm.


Agenda Additions or Revisions – No changes.

Approval of Meeting Minutes – VP Adams called for additions or corrections to the January 10, 2023, meeting minutes. Jeremy Jenkins moved to approve the January minutes as submitted and Doug Greenlund seconded the motion. The January meeting minutes were approved by consensus.

Financial Report – Treasurer Ron Wilson was not present but sent the February Treasurer's Report which VP Adams shared. Invoices for Anne Francis Web Design, Jackhammer Promotions and Reimbursement to Tonilee Hanson for wildflower seed packets amounted to \$1,009.92. Treasurer Wilson's report announced the award of a DEQ Source Water Protection Grant in the amount of \$24,000. The Glacier Family of Banks - Mt. West Bank balance as of 1/31/23 was \$38,425.82. Treasurer Wilson's Financial report was approved by consensus.

Old Business

IWAC Tablecloth, Pens, Seeds Display, and Brochure – The IWAC tablecloths, pens, seeds, and display have been produced. Members reviewed and approved the latest IWAC Brochure design. Tonilee will work to get the brochure printed in time for the Truck Rodeo on 2/22/23.



IDEQ Source Water Protection

Grant – The grant proposal focuses on a media campaign to promote aquifer protection through water conservation and the Outdoor Watering Nerds Website. Graphic Designer Hannah Walker provided a bid for the 6-month media campaign graphic design of digital and social media ads. See Hannah's proposal to the right. DEQ grant requirement have not been received so the members voted to approve one set of ads at the \$450.00 price to ensure that the ads are ready for

New Business

2023 Aquifer Atlas Review and # of copies to purchase. The Aquifer Atlas team provided final edit which were sent to the graphics designer, Amanda Summers. The cost per atlas has not been determined. This item will be considered again at the IWAC meeting on March 14, 2023. When a final Aquifer Atlas design is available, it will be sent to all members.

Review Goals and Establish 2023 Priorities – Tonilee Hanson informed the members that a questionnaire had not been sent to ask members about their priorities for IWAC. A survey will be sent before the March meeting to all IWAC members and interested parties to identify 2023 priorities. Discussion of goals included interest in finding funding for an updated USGS study of the SVRP Aquifer. The last study was done in 2009. Aquifer impacts like climate variability, population growth, and Spokane River Instream Flow ruling need to be incorporated into a new model. Dan Kegley shared that this study would likely cost \$250,000 and take 1-2 years. What would it take to get WA DOH, IDEQ, SAJB, IWAC, APD, Spokane County, Cities, and others to invest in a new study?

Spokane River Forum Conference <u>Registration for the SRF Conference is open</u>. Dates are Wednesday 4/26/23 and Thursday 4/27/23, at the Spokane Convention Center. A session on Water Supply is scheduled for Wednesday 4/26/23 from 1:45 pm – 3:15 pm. Topics include Native Plants with Kara Carleton and Iris Mayes, Outdoor Watering Nerds Water Conservation Website – Tonilee Hanson, and City of Spokane Water Conservation with Kristen Zimmer. IWAC members were asked what they thought of a session on gravel pits and the potential for contamination. Discussion followed. Members comments included the following and more:

- Do we have enough information from our study of gravel pits to prepare a SRF Conference session?
- A session on the risks to the aquifer could foster constructive dialogue.
- Are there any legal proceedings around the gravel pits?
- How would information be shared? We want to develop partners not adversaries with landowners such that we are all focused on protecting the aquifer.

The WA Department of Health and Spokane Regional Health District will present a session on PFAS. They hope to see as many water purveyors as possible at the session to discuss this emerging contaminant of concern for our drinking water supply.

2023 DRAFT Budget – Members present reviewed the 2023 draft budget. The Spokane River Forum sent a letter of requested sponsorship and an invoice for \$1,500. Members reviewed the DRAFT budget and approved by consensus sponsorship for the Spokane River Forum Conference. The IWAC 2023 Budget will be approved when President Pickel returns in March.

Election of Officers – March 14, 2023, Please consider volunteering for the position of President as Terry Pickel is retiring in September of 2023 and a transition period is vital to the success of IWAC.

Nominations for the 2023 Ty Wick Defender of the Aquifer Award – Award nominations from Idaho and Washington are open until April 3, 2023, for the Ty Wick Defender of the Aquifer. Here is the link to the <u>Nomination Form</u>.

Updates Around the Table

Doug Greenlund, City of Spokane, shared that Spokane is conducting a vulnerability assessment study based on the Yellowstone pipeline that runs under the Spokane River A kick-off meeting, scheduled on 2/20/23, is working in collaboration with <u>GSI Water Solutions</u> and <u>Consor Engineering</u>.

Jeremy Jenkins, Liberty Lake Sewer and Water District, Shared that post pandemic the Regional Lakes Conference is rebooting. The Regional Lakes Conference is meeting at Spokane Community College on Saturday 3/18/23. Topics include: surface water, Lake Science, Lakes Associations and more.

Craig Borrenpohl, City of Post Falls, shared that the Association of Idaho Cities announced a Water Summit in Boise, ID. Topics include: PFAS and UCMR5 sampling. The Lead and Copper Rule requires sampling for twenty-nine constituents. Purveyors are given 2 years to inventory service lines for lead and copper. Doug shared that a lead and copper panel discussion is available for free from WA State Association of Drinking Water Regulators. Jim Ekins, University of Idaho Extension, shared that Snow Science Field Trips are happening as well as Realtor Workshops on septic systems and wellhead protections in Bonner and Kootenai Counties. There was standing room only in the last realtor workshop. Realtor workshops will expand to a two-day (six hours per day) format. Interest in expanding Realtor Workshops on Septic Systems statewide has been expressed by DEQ.

Henry Allen, City of Spokane Valley, development over the aquifer is increasing density. Modelling of MS4 basins and thousands of drywells is in process.

Norm Semanko, Parsons Behle & Latimer Water Rights Attorney, shared that the Association of Water Users formed a work group focused on domestic wells and proposed EPA rules for state-wide water quality and meeting the needs of tribal water rights that could impact the SVRP Aquifer.

BiJay Adams, Liberty Lake Sewer and Water District, shared that 2023 water and sewer improvements equal \$3 million. So far in 2023, forty connection permits have been issued. There is a growing concern with finding meter setters and supply chain issues .

Adjourn - There being no further business this 14th day of February 2023, VP Adams adjourned the meeting at 3:10 pm.
