AGENDA

Welcome and Introductions – President Suzanne Scheidt attended the meeting via zoom and requested VP BiJay Adams to run the meeting in person. IWAC VP Bijay Adams welcomed everyone and called the meeting to order at 1:35 pm. Everyone introduced themselves.

Agenda Additions or Revisions – VP Adams proposed that planning the CEU training on SVRPA Bistate Model be tabled to a future date after IWAC has made progress on updating the model.

Approval of Meeting Minutes – VP Adams called for additions or corrections to the February 13, 2024, meeting minutes. Ron Wilson moved to approve the minutes as submitted. President Scheidt seconded the motion. VP Adams called for discussion and the vote, and the motion passed unanimously.

Financial Report – Treasurer Ron Wilson provided the March financials which included check # 3850 to National Color Graphics of \$2,000 for printing Drippy the Water Drop booklets. Treasurer Wilson reported that check #3849 to the USPS mailbox was voided. The Post office records showed the 2024 mailbox fee was already paid. The Mountain West Bank balance as of 2/29/24, was \$40,157.24. Treasurer Wilson met with Christina Laurie MBA, CPA Owner/Managing Member at Alpine Summit CPAs, to review the IRS issues with IWAC's non-profit status. The IRS accepted IWAC filings as a 501C3 for the years up to and including 2020. It is not clear why IWAC's status as a 501c3 was denied for the years 2021 and 2022. IWACs 501C3 status has been reestablished for 2023 and 2024. Due to the loss of non-profit status IWAC has been told it owes back taxes to the state of Idaho and the federal government in the amounts shown below (before interest and penalties).

- Fed- IWAC owes \$1,827
- ID- IWAC owes \$576

- Fed- IWAC owes \$1,848
- ID- IWAC owes \$538

Members discussed the issues. Treasurer Wilson suggested that the tax returns should be submitted with a letter asking for relief. Ron will invite Christina to attend the April IWAC meeting to discuss the issue.

Old Business

Discussion – Review of Final Draft Purpose for updating the 2007 USGS SVRP Aquifer Study – VP Adams opened discussion of Henry Allen's comments to the updated BiState Model purpose statement. A wideranging discussion followed, including ideas about the model being used to simulate La Nina and El Nino cycles, to reflect intensity and consistency of events, high flow and low flow conditions, drought, and declining recharge of the aquifer. It may be feasible for a model to provide an annual time step but not individual storm events. Contamination events were also discussed but this model is not intended to track specific surface contaminants. It is desirable to include particulate tracking. Derek Holom offered to edit the purpose to clarify this issue. The goal is to have the purpose finalized prior to the April IWAC meeting. The final version will be sent out for approval via email.

Discussion – Grant opportunities for funding the updated model.


When the Aquifer Study Purpose/Scope is finalized Ron Wilson will follow-up on his earlier conversations with the Idaho Water Resources Board (IDWR) for potential funding. President Scheidt shared that a \$30,000 grant proposal was submitted to the Kootenai County Aquifer Protection District (APD). It is estimated that an additional \$70,000 will be needed to move forward with Phase 1 of the model update. Other sources of funding were discussed. Scott Mallery suggested that WA DOH Source Water Protection might be a funding source. Tonilee Hanson will contact Nikki Guillot the Source Water Protection Coordinator at DOH.

Planning CEU training on SVRPA Bistate model. Tabled until further notice.

New Business

SVRP Aquifer Water Quality Monitoring Program - Amy Sumner

Spokane County Aquifer Protection Area (APA) Renewal and Regional Water Quality Monitoring Program – Amy Sumner Water Resources Project Manager, 509-477-7578, <u>asumner@spokanecounty.org</u>. Amy shared the importance of the Spokane County Aquifer Protection Area (APA) funds. Below are some of the 20-year accomplishments.



Amy shared the <u>Groundwater Water Quality Monitoring Program</u> data which is available as a <u>full data report</u>, as an <u>Interactive Tableau Database</u> and a <u>SVRP 20-Year Analysis Storymap</u>. Below is an image from the Story Map. "Septic systems treated wastewater outside of the City of Spokane and Liberty Lake Sewer and Water District service areas. In 2008, ~15,000 septic systems were located directly over the aquifer. The County STEP eliminated ~75% of the septic systems overlaying the aquifer, but their use still occurs outside of the sewer service areas."

Many thanks to Amy and the team at Spokane County Water Resources who transformed 20 years of water quality data into an engaging and understandable story.



2024 Budget – The 2024 draft budget was reviewed. Ron Wilson moved to approve the 2024 budget. Suzanne Scheidt seconded the motion. VP Adams called for discussion. Tonilee Hanson reminded everyone that she is retiring on December 15, 2024, and funds may need to be allocated for a new Administrative Assistant. IWAC will need to decide if it wants to continue with the current arrangements in which the SAJB Program Manager supports IWAC or if IWAC will hire a separate Administrative Assistant. VP Adams called for the vote and the 2024 budget was approved unanimously.

Updates Around the Table

Scott Mallery, DOH, shared that Dorothy Tibbetts retired and Marcus Goodman is the new Regional Manager.

Adjourn - There being no further business this 12th day of March 2024, the meeting was adjourned at 3:05 pm.
